### Intrusive external wall investigations to begin in 2023

We're still getting ready to carry out external wall investigations into your buildings, to ensure they have been built to the standard regulations expect. Since our last update in September, we have carried out a desktop assessment and a visual survey of all the priority A buildings in our medium category – this includes your building. This took longer than expected so we are only now beginning to procure relevant professionals for the next step.

Using the information we gathered, we've put together case studies to issue to the fire engineers carrying out the intrusive investigations in line with new PAS 9980 guidance.

#### A summary of this letter

We've caried out a desktop assessment and a visual survey of your building since we last wrote to you.

We're now procuring fire engineers, façade engineers and contractors who will be carrying out intrusive investigations into your buildings external wall system throughout 2023.

# Procuring fire engineers and other services

We are procuring fire engineers, façade engineers and contractors at the same time. Fire engineers and contractors to facilitate the external wall inspection will be appointed for each specific scheme. Façade engineers may be appointed on specific buildings, if we think their input is required. We will be issuing the procurement packs before Christmas and will receive tender returns towards the end of January.

Please look out for more updates from us in the new year, as some of the buildings in our Priority A group will be sent the dates of their investigations throughout 2023. Dates will depend on the availability of the professionals required – there is currently extremely high demand for this type of work. Of course, once we have carried out the investigation at your property, we'll let you know if any remediation is required and what the next steps are.
